Returns prior to the creation of Class A shares (5/8/98) are based on the performance of the Fund's predecessor fund. Returns have been restated for sales charges but not for Class A shares' fees. If these fees were reflected, returns would have been lower.

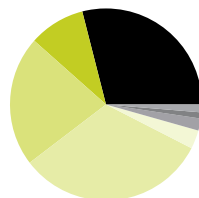

PRINCIPAL STRATEGIES

Under normal circumstances, the Fund invests at least 80% of the value of its net assets in fixed-income securities that are investment grade, including corporate bonds, U.S. government securities and mortgage-backed securities. The Fund seeks to achieve its objective by investing in securities that the managers believe offer the highest level of expected income while simultaneously attempting to minimize the impact of market price fluctuations on the portfolio.

DEFINITIONS

Barclays Capital (BARCAP) U.S. Aggregate Bond Index: An unmanaged, market value-weighted index of investment-grade, fixed-rate debt issues (including government, corporate, asset-backed, and mortgage-backed securities with maturities of one year or more) that is generally representative of the bond market as a whole.

Average annual total returns are the annual compounded returns that would have produced the cumulative total return if Fund performance had been constant during the given period.

Duration is an estimate of bond price sensitivity to changes in interest rates. The higher the duration, the greater the change (i.e., higher risk) in relation to interest-rate movements.

SEC 30-day yield is a mandatory yield calculation for bond funds and is essentially a "yield to maturity" for a fund's entire portfolio. The calculation is standardized, so it provides a good measure of comparison for funds. Because bond funds actively trade and prices fluctuate, this yield may not be a good indicator of future results.

Standard deviation is a statistical measure of risk. It reflects the extent to which an asset's rate of return may fluctuate from period to period.
